# Digital threat, Holistic Solution: One way to combat in Cyberspace

If doubts remain, I announced that in cyberspace there are equal or greater number of threats than we are used to seeing in the analog world (physical), vast make one pass through the network news and see everything that happens from theft identity, grooming, child pornography, cyber attacks varied in form and type.

However, man is accustomed to living under threat and through their intellectual ability to think and plan strategies to combat these threats and thus live with levels acceptable to the uncertainty. Throughout modern history we have seen that this is so, even more is given from the military or government areas, where dealing with threats and opponents and planned under them.

This is clearly seen in the analog world, where every concrete action there is an answer, whether this preventive or reactive. That's how we have seen the Just War or the theory of preventive war appear terms. The man in those years in the analogue environment, initially had linear responses and have been educated. That is to say that somehow our answers were preconditioned, if  $A + B$  then  $C$ , for each question there was only one possible answer or a single way to get to that answer. But the great strategists were realizing that the linear responses did not always results or not always brought the

same results, making decisions nonlinear then appears, a traditional example is the military landing in Normandy, no one expected to be landed on the date of the worst storms, where the voyage was far less unfavorable, it was not logical, however, the solution adopted by the Allies was not linear; as well as this there are several examples that we see.

But what more than 50 years ago was not linear, we could say it was a side thought, today is as usual and expected, no commander make the same mistake, however, that it is no longer linear, but it's not that side, begins to suffer a new distortion, and that distortion is given by the space where it develops, so the 5th domain, cyberspace brings new challenges and paradigms that must be faced. The threat is no longer only analogue but also digital and has repercussions in both worlds (analog and digital).

Here are some of the threats and groups in recent years have been active as to have an idea of where we are. Of course, keep in mind that some highly publicized cyberattacks were obviously others do not, but if information portals for the category:

## **TRITON 2017 attack**

TRITON is one of a limited number of families identified publicly malware targeting industrial control systems (ICS). Follow Stuxnet that was used against

Iran in 2010 and Industroyer believed was deployed by Sandworm Team against Ukraine in 2016.

In August 2017 there was a cyber attack on critical infrastructure in the Middle East (Saudi Petrochemical Company), the attacker gained remote access to a workstation's engineering ICS and implemented under attack TRITON to reprogram controllers ICS. During the incident, some ICS drivers entered a safe state failed, which automatically stopped the industrial process and caused the owner of the asset initiate an investigation.

### **G20 attack in China 2016**

During the realization of the G20 in China, more specifically during the week-long summit attended by the presidents and / or Heads of State they were received or made more than 133,000 attacks targeting network. Bear in mind that during the realization of all the G20 in China 12,728 web applications and special pages linked to the development of the Summit were counted.

To address this issue of cyberthreats and considering that since the 2011 G20 Summit came under attack, the Ministry of Public Security of China required the collaboration of NSFfocus a global provider of intelligent hybrid security solutions. For which NSFfocus adopted a holistic approach and implemented a layered solution, also the company provided 28 systems that offered debugging attack traffic, intrusion prevention and web application security which is updated continuously with a system of intelligent threats own.

### **Turla group to cyberattack**

This is a group of Russian-speaking world cyberespionage, is known for using unique and stealthy tactics. They hit the headlines when their command and control servers (C & C) were found hidden in the comments section of publications Instagram Britney Spears. Malware delivered was presented as an extension / add-on for Firefox security and distributed through a Swiss website committed. In September 2015, they could hide their C & C servers exploiting and abusing Internet services based on satellite unsafe. In December 2014, the group employed a backdoor open source addressed machines running the Linux (OS) operating system.

Chain attack one of his last campaign resembles an employed by other groups cyberespionage Pawn Storm and ChessMaster. Actual events and legitimate documents were used as decoys to install backdoors on machines of their targets of interest.

This allows them to move laterally within the compromised network and steal sensitive and mission-critical data.

As we can see, are many and varied threats that cyberspace can find and so are the answers out there to give. However, one factor that is constant in both worlds (analog vs digital) and both ways of thinking (Lineras vs lateral), and that is the human factor. No matter what the world or thinking you have, the human will be present inexorably throughout the equation, either being who threatens, who is threatened or who protects.

With this in mind, it appears that rather than be aware of the types of threats, whether malwares or APT'sy the type of defenses, first, you must understand that the problem is the adversary we have in front. This means that someone is sitting in front of a keyboard and PC, developing a strategy for entering our environment or system.

The same with cyber operations by which the human factor becomes important, although this is developed in a cyber environment, tactics and techniques seek the same, undermine the system through gain confidence of a human element which then provide information, be aware it or not. And in another article talk about Cyber Operations Intelligence so not worth repeating here. However, again the human factor is present, even neglect to end users by giving them minor forget that they are also part of the safety chain, and as always the chain is as strong as its weakest link.

So to counter cyber threats of today, you must accept the fact that there is no single solution to the problem, we must focus on building a strategy constantly evolving to incorporate new tools, processes, policies, experience and contemplate the human factor his universe, to succeed in ensuring that our data is not stolen, modified, destroyed or kidnapped.

Thus we can say that there is a static solution. A holistic action and thinking is what we must do, it is also going to make sure to understand thoroughly opponents to stop a cyber intrusion. If we can not stop it, then we ensure mitigate the impact by not allowing the opponent to achieve its objective.

The holistic approach involves integrating technologies, processes and people. This practice will depend more on Risk Management Information. This requires an active strategy in detection, recognition, identification, response and remediation of threats.

A comprehensive security program focuses on protection through continuous monitoring and data systems. This involves moving from the traditional

approach of defensive reactivity to a defensive-proactive approach (predictive) using cyber analysis to promote "security intelligence" that also protects privacy.

The OMB and NIST mandates now require continuous monitoring, which can be complemented by the use of ciberanálisis to highlight the risks and proactively identify, monitor and address threats. As businesses strengthen their security defenses, predictive analytics plays an increasingly important role. Companies can perform sophisticated advanced persistent threats to detect correlations, while implementing IT governance and enterprise risk automated processes, key elements to enable security intelligence.

**This includes the ability to:**

- Identify patterns of previous failure and external threats to predict possible areas of attack;
- Analyze the internal behavior patterns to identify possible misuse; Y
- Monitor the external environment for potential security threats.

Specifically, cognitive solutions have three critical capabilities needed to achieve security intelligence:

- **Commitment:** These systems provide expert to develop deep domain knowledge and present information in a timely, natural and usable way assistance.
- **Decision:** These systems have decision-making capabilities. Decisions made by cognitive systems are based on evidence and continually evolve based on new information, results and actions.
- **Discovery:** These systems can discover ideas that might otherwise not be discovered. The discovery involves finding ideas and connections and understand the vast amount of information available.

By using these systems, executives of the agencies involved in cybersecurity can move from one to one optimized security intelligence basic level as described below.

**closing thoughts**

As we see, the digital and analog share the essential element, the Human, is where everything is born and where it ends. In these societies who are complacent technology, seems to dispel the impression of humanity, however, we see that is not so simple.

Technology development continues to evolve with the introduction of new innovations to address cybersecurity framework including networks, payloads, endpoints, firewalls, antivirus and encryption software. This framework will provide better resilience and forensics. Some newer areas of investment in cybersecurity will be the areas of cloud, authentication, biometry, mobility and automation, including self-encrypting drives. And, of course, supercomputing and quantum computing.

Automation, including artificial intelligence, is a way of emerging and future cybersecurity. In an effort to better protect the government cyberspace USA, the Department of Homeland Security (DHS) has implemented an automated cyber-surveillance that monitors federal Internet traffic for malicious intrusions and provides an identification near real-time activity EINSTEIN 2 malicious call.

However, to incorporate real protection cybersecurity, Holística, we should not ignore the importance of the human factor, an awareness of basic safety of employees, establish security protocols and have a skilled workforce and permanently trained.

Achieving cybersecurity protection preserves the success of the mission while key objectives for the security program of the government agencies and companies are achieved. In developing a truly holistic and intelligent cybersecurity, you can go from a basic position (manual and reactive) to optimized (automated and proactive) to protect critical systems and valuable information held. While no progress in this direction, we will live in the XXI century but with reservations 20 years ago.

## Among the they killed and she died alone

Phrase is normally say or applied in Spain when more than one individual, group or movement intervened actively or passively to create and fatten a problem and after the fatal outcome thereof, normally, none of them assumes responsibility for this result and even at the beginning of it.

This is what we have lived in Spain in the last week. A censure motion against a government that after happy prometérselas nothing approve budgets, a few hours before, has cost him the post and governance of a country that after many difficult problems was in the final stages of improvement international and a clear and almost clear economic recovery and social prestige.

Recently published in these same means work to which I titled Quo vadis Spain [1]. In it he explained, in detail, the political situation, arguments and fallacies in which the motion was based and outlined what my forecast most likely could happen. Also he announced that everything was possible, although this will require genuine aberrations are getting the necessary support in this operation. Operation, contrived and mumbled for quite some time back, feigning some improvisation, which has been fully

oiled after repeatedly declared authentic LIES to create a false atmosphere of widespread lack of confidence in the government, repudiates its policies and the need for democratic cleansing which only achieved with the cancellation of the Popular [2] Party.

Operation that was culminated with a malicious outstretched hand disguised as a "dignified exit" to the situation materialized with the resignation of Rajoy, which in reality was no more than a second humiliation double act since the success of this output, to be effective, needed the direct or indirect of those who had concocted the problem support. Support which, incidentally, was requested clearly and publicly, in parliamentary seat repeatedly and explicitly both Rajoy as the PP spokesman candidate Sanchez and others involved as citizens and they did not get more than smiles accomplices to the pure bratty kid style it is known discovered by their parents or guardians in one of his lies and mischief.

We have a new Prime Minister who has reached this position against most forecasts. It seems that the PSOE, in this century, is unable to reach the presidency of the government as it should be: with

foundations, programs, calmly and after a totally unhurried and fair elections. It is the second consecutive time that the PSOE PP tomb suddenly, without being prepared for it properly before and with Sadducees, liars, exaggerated and clattering arguments; transgressing many difficulties, concocting plots nonexistent. It does so by using legal means, but personally I believe, some legitimate or at least not very clean [3]. This time he explained the explicit support of all radical parties, separatist, nationalist, xenophobic, populist,

Also he pointed out in that work were few arguments that the possibility of the sad outcome of this situation was based and that this would require the combination of many acts and actors and certain concatenation of rebound effects that clearly and accurately influenced one in others.

To see in detail the latter should look first at the candidate himself, Mr. Sanchez and his party PSOE. A party that, having him as Secretary General, was aware that while his standing among voters and followers was increasingly declining-losing votes and seats in last two consecutive elections in 2015 and 2016 and with a tendency to quietly. To this must be added that wear party produced its totally obstructionist stance and dangerous overture in 2015, to try to form a government, to the aforementioned parties which caused the literal expulsion of Sánchez from office and almost, his party.

Called barons of the PSOE alarmed by the burden that could mean receiving some unsavory and malicious support in exchange for meeting the personal deficiencies not achieved in the polls and impossible perquisites that those could demand in exchange, they decided to appoint a manager to take the reins of the party and recondujese the former vocation of the socialist party service to Spain and stay away from inventions and governments who, in turn, were qualified by the own party "governments Frankenstein" by clearly go against the idea of the PSOE and maintenance and development of the State according to the Constitution of 1978.

Then defenestrado Sanchez, he took the basket of groundnuts and cravenly abandoned and the back door -to his seat in Parliament did not follow the guidelines of the management aimed to give a solution to the impasse; after nine months of political paralysis in Spain forced and created exclusively by himself and even at that time and according to some of his associates, was in a trice to leave politics. Which he did not, thanks to a handful of stalwarts, its more than known stubbornness, his enormous ability to create and store the rancor and because, really, to

live outside the mamandurrias of this, he offered few alternatives since no known major professional accomplishments outside of politics,

With this sad background and with the strong hope of recouping the offenses suffered, decided to battle again, starting from the bottom and face the large group of barons who trusted their own majorities and forces within the party was given by totally out of focus, love their incipient movements and decided not to waste time in heeding the capacities and capabilities of their intriguing maneuvers which, step by step, he sought the support of the bases (affiliates) in the purest populist style of Chavez, mature or churches. Style that has always given and continues to give results filibusters and that they only resort at times they are interested as we have seen there in Venezuela and how to solve the so-called case "of no small villa with swimming pool and house guest "; but not to make major decisions such as filing a motion to censure the government. At that time, everyone was convinced that Sanchez had nothing to do and, just in case to shut all the doors, even made spread the idea that if this triumph, it would be the origin of the end of the PSOE [5].

As a result and mismanagement by the party of the foregoing, beat unsuspecting closed and defenestró to the manager, he put his great conditions "survivors" hostile barons and delayed almost ostracized anyone charge or socialist deputy He would have made any ugly or had openly opposed his claims. Again, he acted with the best and unsophisticated populist style based on revenge.

After a year of it all, we find that Sanchez had regained his inner power but did not own seat in Parliament, recent surveys continued systematically giving a decreasing number of votes and seats for the party under his leadership. Churches (Podemos), once surpassed the subject of his casoplón, returned to print certain speed at takeoff of his party and already pointed at this time could itself face the oft-repeated and never reached Sorpasso. On the other hand, the restless, continually changing, anxious and unreliable Rivera (Citizens) seemed to surround all electoral preferences and finally, and by no means negligible, the government had just given his greatest displeasure; approve budgets that gave wings to continue in his position until almost or the end of the legislature.

A dangerous combination that influenced much on the screen popularity and staff mangoneo and party arrived, again and most likely, on the verge of minimum expression and importance ahead of the upcoming local, regional and European elections and



few hopes for general within a year and a half or two years at most.

To make matters worse, he had to signify important events in your fascia and feeble-for doing many repairs and very harmful exigencias- "sense of state" with the theme of Catalan separatism and "undermined and calculated support" to the application Art. 155 of the Constitution and the role of government leadership in this.

A government that very reluctantly, still in the hands of its unpalatable and hated enemy personnel. Rajoy serious error that has cost him dearly, because it failed to see the reality of the situation and the consequences of those, I believe, sincere words.

They were the last straw, the PSOE and almost disappeared Secretary General were on the verge of the most spectacular failure, on everyone's lips and away increasingly leading the opposition to the government much they had endeavored to knock the management of their future budgets. So much so, that many surveys and sent them to fourth place in the ranking of popularity and voting intentions. He had to do something important, resounding and quick to give a Copernican twist to the situation.

Although I have no legal or legal training, I know that when a person is summoned as a witness in court (if Rajoy and other members of the PP in the trial of Gurtel) has an obligation, under penalty of committing a crime, always say the truth in his statements. If it were not so, the Court must precede against the declarant for lying in court as a witness. # Geographic expansion of jihadist terrorism: Mozambique

## Introduction

Mozambique with 25 million inhabitants and an index very low human development, officially has a 17% Muslim. The great social and economic tensions in the province of Cabo Delgado in the north, help analyze, jihadist propaganda in the region, to achieve justice through the establishment of an Islamic State, which finds acceptance in youth.

## II.- Origins of the conflict.

2015: Surge "Ahlu Sunnah Wa-Jama", which means "followers of the prophetic tradition" through networks of Al-Shabaab in Tanzania, Kenya and Somalia.

Bases jihadists Cabo Delgado Province:

- Mocimboa da Praia
- Macomia
- Montepuez.

External training camps:

- Great Lakes region
- Kibiti (Tanzania)

Leaders: Nuro Adremane and Alawi Jafar

470 Detained OCT2017- 01JUN2018:

314 Mozambicans, 52 Tanzanian, 3 Ugandan, one Somali and 100 unknown

### III.- Recent Bombings

MAY- JUN2018: 39 dead and 400 displaced by attacks in northern Mozambique, executed by the new jihadist group Al Shabab, which uses the name of the eponymous Somali organization, although unrelated to it.

05JUN2018 7 civilians killed (stabbed) and several houses torched by Islamist terrorists of Ansar Al Sunna (Protectors Sunna- faith). Locals call it "Al-Shabab", in the village of Pemba, Cabo Delgado. Speak Portuguese, it includes terrorists from Tanzania and Somalia.

29MAY2018 10 beheaded (2 young 15 and 16 years) with machetes and knives, in the Province of Cabo Delgado, by jihadists of Al Shabab (youth in Arabic)

06OCT2017: 16 Islamic terrorists and 4 policemen killed. Jihadist attacks 3 police stations Maculo, Mocimboa Praia, 80 km from natural gas fields. 10 terrorists arrested with rifles.

### IV.- Conclusions

The Islamic State (Jahba East Africa) is played with Al Qaeda presence in East Africa (Somalia, Kenya, Democratic Republic of Congo, Uganda, Tanzania) and currently includes Mozambique and South Africa.

Geography terrorist expands to South Africa where Muslims were stabbed in an attack on a Sunni mosque in Malmesbury, Western Cape (14JUN2018. 2 dead and 3 wounded) at the end of Ramadan. Also the 10MAY2018 there was one dead and two wounded, stabbed by 3 men in a mosque in Verulam (Durban), in the month of Ramadan.

Concerning South Africa, it is noteworthy that Muslim immigrants from Asia (particularly India), Central and West Africa, studying in madrassas (private Islamist schools) and then dozens of graduates entering with South African passports to Sao Paulo (Brazil), to preach and make contacts with support networks to Islam in South America, it is estimated that they can infiltrate including fake sheikh.

# PMCs

The society in which we live is constantly changing in every sector, especially in the military sector, which has seen a rapid development of private agencies (PMC) to carry out their activity in areas of the world where crisis level is high. non-state armies to protect large multinational companies operating in those areas.

The PMC perform various services, such as close protection of embassy personnel, information and intelligence activities, operational support so that we can delineate three areas involved:

- Providing men and resources directly involved in the conflict;
- Only agencies offering advice and training activities not directly involved in the conflict;
- Agencies offering logistical support such as refueling and transport operating in the rear of the battlefield.

PMCs are real economic companies regularly registered and listed on the stock exchange, therefore, the motivations that drive operations are very economic in nature and not political.

From a legislative point of view, there are several international legal instruments that regulate the activity and employment in a military context,

although slightly incomplete: the Organization of the Convention of African Unity for the elimination of mercenary activity in Africa 1977 the art. 47 of Protocol I to the Geneva Conventions of 1977, the Convention of the United Nations Convention against the Recruitment, Use, Financing and Training of Mercenaries of 1989, in the United States proposal by Republican Senator Graham, a law was passed in 2007 that allows detain members of these companies who commit crimes to be tried by military courts in the United States.

Let us now analyze the positive and negative aspects of the use of these private companies. The economic factor always favors: the use of PMC reduces costs that politics should keep to wage war, particularly during the stabilization of the area in postconflict also costs for training of regular troops to be sent to war zones are reduced, finding against professionally trained men and valid as from military areas and who have left their units attracted by higher returns. To say that these agencies make their money because there are conflicts and have no interest in cessation, there is also a psychological problem: the operators of these companies linked to

them by a contract perform the task assigned to them to achieve the goal,

In conclusion, it is likely that the use of PMCs constantly increase, even if the sector requires specific laws and regulations requested by the very agencies that regulate the sector from the point of view of operations that may be subject. We can

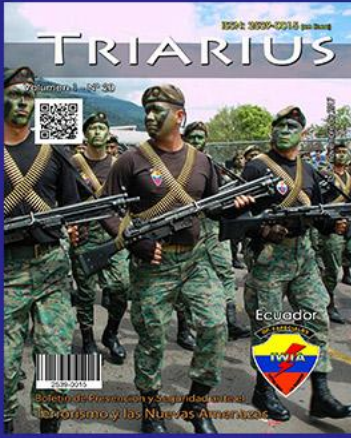
hypothesize the use of private individuals in the fight against the terrorist threat and the fight against drug cartels and the maintenance of international peace and stability. For the United States the PMC have become irreplaceable in areas such as Iraq and Afghanistan.

Sanchez, et al (2007) quoting different authors, synthesizes a very interesting definition, noting that

*(...) the intellectual capital includes not only the potential of the human brain, but also trademarks, names of products and even investments the company made in the past and although accounting have not been revalued, the market If you have made. That is, within this concept includes all assets that have value for the company and that currently are valued at zero by it. Therefore, intellectual capital is made up of all intangible resources and their interconnections, considering as resources to all those factors that contribute to value creation for the company and that are, more or less directly under the control this. (Pp.99-100)*

According to this definition, and in the interest of measuring what is the value of intellectual capital of an organization, an approach would be the difference (or gap) between the market value of a company and its book value strictly. As already mentioned, this would be only an approximation, for measuring the intangible especially if you want to get data desagregados- is quite complex. For this we have developed different methods of measurement. In the particular case of the security and defense sector, measuring the value of intellectual capital can be even more complex since "security" and "deterrence" they are also intangible concepts.

Another element to consider is that the above definition encompasses much more than that strictly referred to the people. In this vein Sánchez et al (2007) indicate that there are three dimensions that together determine the intellectual capital. These are: Human Capital, Structural Capital and Relational Capital. The first dimension is shaped in turn by the skills, attitude and intellectual agility that has the staff.

As for the structural dimension, "that knowledge that the company has been able to internalize and remains in the organization, either in structure, in their processes or their culture, even when employees leave." (P.105 )

Relational Capital "includes the value that the company's relations with not only customers, suppliers and shareholders, but with all its stakeholders, both internal and external." (Sanchez et al, 2007: p.107)

Obviously these three dimensions of intellectual capital are intrinsically linked. Since these relationships may not be the best (or even harmful), it

is where comes in management's ability to redirect efforts to restructure what needs to be changed, and generate all the synergies that help increase the results for the benefit common.

Now, with this theoretical and conceptual framework and from the business field, it is possible to argue that an overly protective for workers legislation, ends up affecting the quality of intellectual capital, and thus negatively affecting the efficiency and results of organizations, and this as in a domino effect structurally also impact on the country's economy, making it difficult to improve or worsening macroeconomic performance and collective welfare. There will be less public money to invest in essential State functions, including security and defense issues.

Ugalde (2011), tells us that "there is a general conviction that the survival of companies and their ability to generate profits are closely linked to its ability to reinvent itself." (P.464). That is, that innovation is essential to the survival of organizations. It further clarifies that the main source of innovation is the intellectual capital that among other things-improving products and services and the efficient use of resources.

Govindarajan and Trimble, cited by Ugalde (2011), "state that innovation and routine operations are inevitably in conflict, because organizations are not designed to cope with change but to a reliable and consistent execution."

Thus, an organization is in serious trouble when you have a group of employees who are not the most appropriate, which the law protects against "unreasonable" or job security, dismissal that must provide all the benefits of protection and social security, and in many cases abusing sick leave or maternity. Personal with these characteristics, can hardly be motivated to self-improvement aimed at strengthening the intellectual capital of the organization. It can not be replaced quickly to combat entropy and inefficiency. In this vein, although neoliberalism and absolute labor flexibility is an undesirable end to the collective welfare and dignity of life of the population,

In the field of security and defense, Latin American military and police institutions are treasuring traditions and resist change. In addition, often not encouraged the development of intellectual capital. After reading these lines will be understood the inadequacy of this situation. Modern military forces must be in permanent transformation, not only adapting to new scenarios but, and especially, anticipating them.

## Institutional weakness in Peru

The scandal of international construction conglomerate based in Brazil, Odebrecht, has been targeted several Latin American leaders, dynamics began with Brazilian exmandatarios Dilma Rousseff and Luiz Inacio Lula Da Silva, but the phenomenon of corruption is not stop there, already have involved numerous political figures in the region as "the biggest case of foreign bribery in history," as he called the State Department of the United States (Department of Justice, 2016), for a scheme to pay hundreds of millions of dollars in bribes to senior government officials in different countries.

The system was based on finance expensive campaigns of presidential and parliamentary candidates, or involve intermediaries to reach the centers of power in exchange for building permits, petrochemical and engineering through lucrative public works concessions or laws favoring them their interests.

In the particular case of Peru with respect to the current government in December 2017 Odebrecht informed Congress that had paid US \$ 4.8 million two consulting firms linked to Pedro Pablo Kuczynski between 2004 and 2013, this added to an alleged buying votes from some parliamentarians to avoid the dismissal of the president and constant pressure from the fujimorista opposition led to Kuczynski act one day before Parliament voted his dismissal, was

the second motion of this kind in just three months (El País, 2018).

Pedro Pablo Kuczynski is the first president in office to fall by scandal, before being submitted to a vote of impeachment in Congress, the president resigned arguing that given the difficult situation that has arisen want it to appear guilty unfairly by acts which did not participate, they said in a resignation letter submitted to the Congress on 21 March.

The president has always denied the charges against him despite the revelation of some videos, in which government officials by offering bribes to members of the opposition in Congress to try to prevent his dismissal appear. What is clear is that his resignation is a blow to the country's institutions, which should not only deal with what happens in the current period of government, as has been engulfed in a wave of corrupt practices in other arrangements.

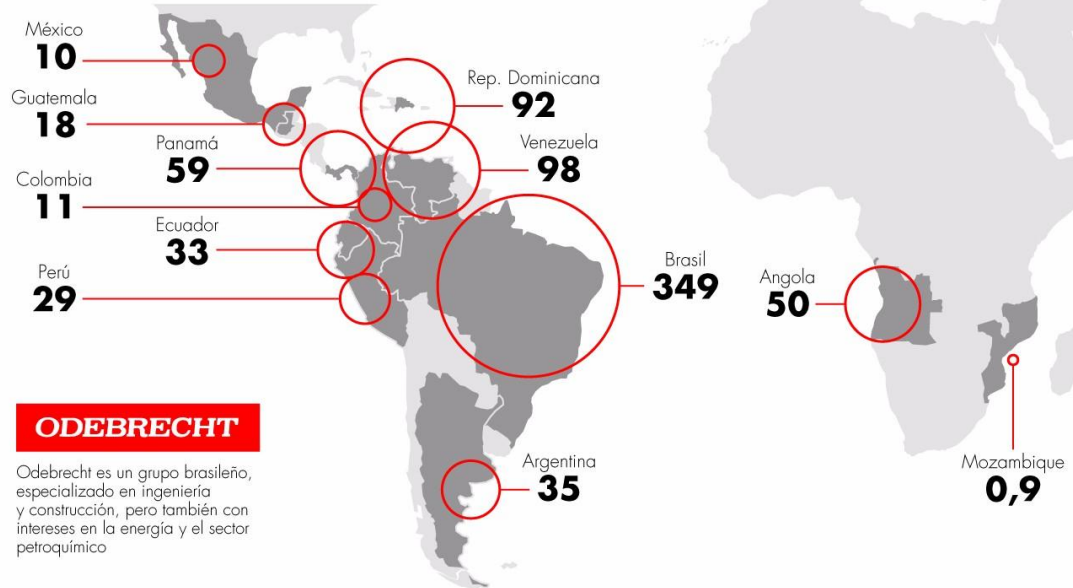
Fujimori (1990-2000) 1992 starred in a coup and established a regime characterized by corruption and human rights violation. Democracy was recovered in 2001, however, the calm did not last long. Alejandro Toledo (2001-2006) has order of arrest in the United States to benefit from US \$ 20 million and Alan Garcia (2006-2011) is targeted for bribes to win bids in his government, as to Ollanta Humala (2011 - 2016) and his wife are in custody for receiving allegedly US \$ 3 million for his campaign, plus the opposition Popular Force, Keiko Fujimori, is also

being investigated for money laundering during the presidential campaign of 2011 (Infobae, 2017).

Clearly in the country continues fujimorismo through the political heirs of Alberto Fujimori, who have an important role in the chaotic scene of the country, on the one hand is Keiko, opposition leader with a populist and destructive discourse and Kenji who he made a pact with former dictator Kuczynski clemency in exchange for 10 votes that prevented the president fell in December (El País, 2018).

Consequently, the humanitarian pardon granted to convicted Alberto Fujimori for crimes against humanity, the Inter-American Commission on Human Rights (CIDH) warned of the impact of the political crisis in terms of human rights, as well as a possible violation of due process for Kuczynski's resignation.

The Commission also noted with concern the political context of Peru, in the context of corruption investigations that resulted in the opening of impeachment proceedings conducted by the Congress of the Republic of Peru against the President of the Republic, Pedro Pablo Kuczynski, in which the guarantees of due process and ample defense might have been violated. As part of this process, the Commission also expressed concern about the influence that the political crisis generated by the order of presidential vacancy raised in

Congress could have generated on human rights, in particular on the decision of the President of the Republic to grant the humanitarian sentenced for crimes against humanity, Alberto Fujimori pardon.

In this context where they have been involved presidents, regional governors, former ministers and officials of the last three governments for taking bribes it has increased mistrust of Peruvians to the state. According to the Tenth National Survey on Corruption Proética, the perception of corruption has increased in recent years. 2017 was positioned with 52%, 6 percentage points higher than in 2015, the last year of measurement, in turn, 62% believe that corruption of officials and authorities remains the main problem facing the State ( Proética, Peruvian chapter of Transparency International, 2017).

As for management Kuczynski only 24% of respondents felt that their work was effective in the fight against corruption against 75% who think otherwise. So it is a paradox that in the 2016-2021 government plan PPK -Peruanos By Kambio-, one of the four main objectives was focused on the fight against corruption:

Peru faces the threat of growing corruption in its public administration and the administration of

justice. Our government apparatus, too complicated and ineffective, promotes corruption. We must implement reforms that actually root end to corruption and impunity at all levels of our society. ("Government Plan 2016-2021 -PPK- Peruanos by Kambio" 2016, p. 4)

Reforms fell short, while the actions squandered the trust of Peruvians were at significantly increased both by President Kuczynski as the judicial system. Still, one should not underestimate the progress of the country which had become a relatively stable democracy, ended a civil war against the Shining Path, resolved conflicts with its neighbors, despite the institutional crisis, had sustained economic growth and exceeded poverty.

The counterweight to the complex political situation is economic stability, surprisingly, despite the current setbacks, Peru has been growing at an average of 5% in recent years. By 2018, the International Monetary Fund (IMF) and the Ministry of Economy and Finance (MEF) projected growth of 4%.

Growth in 2017 was 2.5% and the country emerged as the nation of the Pacific Alliance highest increase in exports, with an annual rate of 22.6%, so it managed to be located above Colombia (19 %), Chile (9.9%) and Mexico (4.4%).

The dynamism of the country was mainly due to increased exports in the sectors of oil, mining and agribusiness line. So, for 2018 there is a positive scenario in which factors such as investment will be key players. (Money, 2018)

While it is a respite that the economy going forward, should not be underestimated the institutional crisis since corruption can have a strong impact, affecting public finances and the country's image, driving away investment. To mitigate the effects, it is necessary to strengthen transparency

practices in public accounts and encourage citizens the repudiation of corruption, in addition to legal and legal actions that should be imparted to punish officials involved in scandals.

For now it is not known whether Kuczynski face charges, however, is under investigation and the judiciary has paved their homes and prevented from leaving the country. It is a fact that their situation sets a precedent, so part of the claim of the government apparatus will take decisions if convicted of the charges against him. How unwrap Peru to resolve the crisis will be an example for Latin America, ahead of the decisive elections in the region.

On the other hand, Martin Vizcarra, the successor has a transparent political criminal record, faces a Herculean challenge, move forward one of the objectives focused on the fight against corruption in a hostile environment and under pressure of an overwhelming opposition, since the congress is dominated by the party of Keiko Fujimori. To this end, it will be key to change the perception of the public and that could support an anti-corruption campaign.

In addition, you must seek legitimacy with his Cabinet to demonstrate that it is a different and efficient management and have a greater margin of governance. Strong leadership and strong institutions are pillars of change, currently nonexistent in the country.

Finally, in the short term, the new president must consider the next VIII Summit of the Americas to be held in Lima, and expected to attend the US president, Donald Trump and 34 other governors. Kuczynski's role was central to the issue of the Venezuelan crisis, the economy and the free market, so Vizcarra must return those issues so they are not off the agenda.

## CANADA

### Canadian Special Operations Regiment (CSOR)

The unit has its roots in the First Special Service Force (FSSF), the unit of Canadian-American special forces rose in 1942 and the nickname "Devil's Brigade" was won by daring night raids against German forces in Anzio beachhead.

Recruitment to form the Special Operations Regiment took place in early 2006, and the first course selection CSOR was held with about 175 candidates.

The Canadian Special Operations Regiment (French: Régiment d'opérations spéciales du Canada, ROSC) is a Special Forces unit with the capacity and responsiveness to operate in austere environments throughout the conflict. It is optimized for a mobile force with the agility of lead and support a wide range of special operations missions, including special recognition, special warfare and direct action.

The unit provides capabilities to Command Special Operations Forces of Canada (CANSOFCOM) across the spectrum of SOF and can accommodate dynamic security environments by focusing on the basic skills of Special Operations Forces.

CSOR uses the indirect approach to establish partnerships SOF abroad through operations of military assistance, in order to prevent or deter the crisis. This allows Canada to respond to crises by building a regional understanding and generation of access and influence.

In times of crisis, CSOR provides a robust, flexible, high available expeditionary force that can be deployed abroad or in defense of Canada. CSOR provides command and control, maneuvering and greater firepower to



support all CANSOFCOM units. This force can be used as a strategic framework for the Government of Canada active and is able to perform operations penetration, attack, capture and control.

The regiment suffered its first casualty on June 24, 2011: Master Corporal Francis Roy-died in non-combat incident while deployed in Kandahar province, Afghanistan.

In 2013, the unit competed in an international competition held in Jordanian special forces, occupying the 3rd place after the teams of the Special Police of China won 1st and 2nd place.

In March 2015, Sergeant Andrew Joseph Doiron was killed by friendly fire while serving in Operation Impact on Iraq.



The Regiment maintained its presence in Afghanistan from 2006 to 2014 in support of Canada's mission in Afghanistan.

Under the auspices of Capacity Building to Combat Crime Global Affairs Canada, CSOR has trained with both the Jamaica Defense Force and the Belize Defense Force, culminating in Exercise Tropical Dagger.

CSOR participates in Exercise Flintlock, an exercise focused on Special Operations Forces planned, coordinated and implemented by African partner nations and sponsored by the US Africa Command.

CSOR currently involved in CANSOFCOM commitment to Operation Impact, in support of the Canadian Armed Forces to the Global Coalition Against Daesh in Iraq and Syria.

In fulfilling its mandate, the staff CSOR has been recognized for its operational excellence, as receiving various decorations for Valor, mentions the Chief of Defense Staff, Mentions in dispatches, medals for meritorious service, among other honors and awards.

## **CANSOFCOM**

While the regiment is composed of personnel from the Canadian Army, Royal Canadian Navy and Royal Canadian Air Force, is part of CANSOFCOM, a joint command reporting directly to the General Staff of Defense, responsible for providing Forces agile Special Operations and ability to operate across the spectrum of conflict both domestic and abroad. CANSOFCOM comprises CSOR, Swarm Aviation Special Operations
