

Environmental terrorism in the Amazon

A 2005 study by Major Robert Arthur Baird of the School of Advanced Combat US Navy. . UU, called "Piroterrorismo: the threat of forest fires induced as a weapon of mass destruction future terrorist" (Pyro-Terrorism-The Threat of Forest Fires Induced Arson as a Future Terrorist Weapon of Mass Destruction). It may seem like a new concept for us, but it is an issue that has gained increasing attention from scientists and military studies abroad. Use of forest fires to damage a nation can gain similar to those of a weapon of mass destruction, mainly driven by broad political purposes proportions. A strange attraction for terrorist groups who want to do great damage without the risk and cost of using conventional weapons and bombs. Al Qaeda, for example, has long used indigenous methods to attack their targets. Dick Mangan wrote in

2005 that American Indians used fire to destroy rival tribes, which re-emerged strongly in the XXI century. This study commander Baird continues to demonstrate that the difference between arson and piroterrorismo is that the latter is more serious. While the former has an individual goal, the second aims at an entire population in order to jaquear a government and create political or social expectations. This explains the divergence between characterize as a simple fire or terrorism.

Since World War II, America has been the target of such terrorist tactics, considering that about 9,000 Japanese bomb balloons were launched on its west coast.

Fires in the Brazilian Amazon, which began in early August 2019, according to research, were caused because the fire started in a coordinated manner at different locations. Brazilian President Jair Bolsonaro, has not only taken the necessary measures to control environmental aggression, but has taken the opportunity to accuse environmentalists, NGOs and in particular, withdrew their anger against indigenous peoples.

Since taking over as president, he had declared his intention of transforming the Amazon into a "multinational empire". The fires are the result of human action, whether accidental or deliberate, because we can not ignore the ambitious plans made by several world powers to exploit the riches of the Amazon, listed in textbooks in the United States and territories they are under its control, for the "preservation" of the global environment. This is because many NGOs and foundations of all types use the hegemonic power to form insurgent wars, which are applied against Latin American countries in a silent invasion.

During the arrest of Israeli soldier Rotem Singer in Chile, supposedly on vacation, he was arrested as the author of Fire in Chilean biosphere reserve in Patagonia in Torres del Paine National Park in 2012, burning approximately 17,000 hectares. A clear example that strengthens the suspicion that the fires in Brazil were also brought. To get away with it, Singer reached an agreement of \$ 10,000 (\$ 7,530) in support of a reforestation campaign and pledged to volunteer for the global NGO JNF 'delegation in Chile. Properly investigated, fires in Chile and Argentina were hidden from the population as environmental terrorism. And in Brazil there are times and knowledge of the irrational ambition of the great powers in order to seize their natural wealth. The state of Amazonas is larger than Europe, a very large fire to cover and control area, however, because of this territorial factor, not enough people to investigate how the fire started.

President Bolsonaro argued that the fire could have been caused by opposition to his government and many NGOs had stopped receiving money from Germany and Norway. Another hypothesis is that it may have been "farmers, Indians and ranchers."

Meanwhile, the media have silenced the tragedy, which is another form of environmental terrorism, making them accomplices of the new crime against nature and against the native peoples whose home is this jungle.

Suspicions of President indifference to this situation have emerged as part of plans to 'clean' indigenous communities, blacks, the poor, homosexuals ... based on its precepts 'evangelicals' "Nothing better than predator and purifying "fire, but they are only predictive assumptions opposition, since it has been shown that the positions of Jair Bolsonaro differ on this issue in the course of this year to meet its commitments to the President of the United States, Donald Trump and Israeli Prime Minister Benjamin Netanyahu. The speeches of indigenous women leaders in the Brazilian Congress were strong, desperate and very clear about the threat to them, as large mining companies and other companies entered the region. The native peoples of the Amazon are the best caretakers of their land and nature.

Because of the selfishness of their proposals, shown in the reaction of world leaders, we observe the intensification toward the fire damage this is causing to countries, but soon refer to humans, fauna and flora.

Actions and Bolivia under President Evo Morales, when the fire in the Bolivian Amazon region, put into operation and contains helicopters and airplanes and all people on alert, creating a crisis committee.

The differences between a term and another raise questions: first, the representation of the extreme right, capitalism and, secondly, an indigenous leader who took office in Bolivia with a speech of peace.

Open Democracy organization claims to have had access to internal documents and the Brazilian government intends to implement a conservation project and advance the exploration of the Amazon. According to the NGO, the government has as one of its priorities inhabit the Amazon region to prevent the implementation of multilateral forest protection projects, called 'Triple A' (Andes, Amazon, Atlantic), which would be an ecological corridor with 135 million hectares rainforest and join the Andes to the Atlantic through the Amazon.

"While this is part of the dark depths that moves behind the colonial ambitions to seize the Amazon, this region can only be addressed, as it has been so far, for their rightful inhabitants of centuries". It is notable in this paragraph, there is no need to appropriate the Amazon, because this region in question, and he was part of Brazil!

Because of what has been presented in this text, the media uses the case to try to burn the image of the President of the Republic, Jair Bolsonaro, because it causes many arguments among the Brazilian population, NGOs, ...

Gospel According to Prime, Brazilian Flávio Augusto billionaire, who owns several companies in Brazil, such as Orlando City SC in the US. UU. and Wise Up, claims to be a terrorist attack, an act designed to cause fires in the Amazon rainforest. Raquel Dodge also notes that, Attorney General of the Republic, reinforces the thesis of the action orchestrated fires. The statement was made after the meeting with members of the Task Force Amazon, founded by PGR to discuss the issue of fires. Who would be interesting to expose Brazil this?

The damaging event that continues to devastate the

Amazon could have a catastrophic effect on humanity as deaths, said Michelle Bachelet (UN High Commissioner). This Chilean woman devoted much of his speech to the Human Rights Council in Geneva sessions on the global climate crisis, noting that could be a source of serious and widespread human rights violations. With regard to burning the Brazilian side, specifically in the Amazon, to prevent further and future tragedies, he asked the authorities to provide more incentives for sustainable management, also applying to Bolivia and Paraguay.

Commissioner faced attacks on environmental activists and those who defend the rights of indigenous peoples and their lands in Latin America. Bachelet said: "I am discouraged by this violence, and verbal attacks by young activists like Greta Thunberg (currently leading youth protests against the UN headquarters in New York) and others."

With a record number of fires in the Amazon rainforest, international leaders join forces to stop the destruction, as the German Chancellor, Angela Merkel, and French President, Emmanuel Macron said.

However, these appeals are making fun of Brazil, as there are jokes about Norway and Germany if they withdraw funds for international aid, observation by climatologist Carlos Nobre.

President Bolsonaro promises to allow more agriculture and logging in the Amazon. Given this, the international community is exploring other options.

Leo Varadkar, the Irish Prime Minister has rejected its

intention and vote to block the trade agreement between the European Union and South American nations if Brazil does not stop the fires in the Amazon. Finland, the presidency of the European Council has called on the EU to ban Brazilian beef from their markets. Brazil relies heavily on exports of soybeans, beef and sugar.

Colombian country has northern part of the Amazon and is mobilizing to contain the burning approaching their territory, willing to cooperate with its neighbors, as well as Paraguay and Bolivia are fighting other fires.

Yemen: More storms in the Gulf.

Yemeni-led resistance front Ansarolá or Hutíes as is known, continues its devastating offensive against Saudi Arabia, which does not find the way to put out the fire that ignited in March 2015, and now threatens to consume the royal family like the fire that consumes two of its most important sites.

On Saturday it was learned that a squadron ten Yemenis in the framework of the operation drones "Dissuasive Balance II" attacked the facilities of the oil Saudi Aramco in Abqaiq, 450 kilometers away from the Saudi capital, the largest plant oil processing the world and the Khurais complex in the eastern province of al-Sharqiya, about 160 kilometers from Riyadh, the capital of the kingdom, which has estimated reserves of 20,000 million barrels of oil reserves. With these attacks the Yemeni resistance encourages you the most devastating since the beginning of the war hit. A senior Yemeni, General Yahya Saree warned to Riyadh more and larger punitive operations.

The attack, which took place from intelligence reports received from within the same realm, demonstrates the extent of resistance, which, from a year ago, a defensive attitude clearly passed the offensive.

Saudi authorities acknowledged that a series of explosions occurred in the early hours of Saturday, which have caused major fires in the listed facilities, which have come to see several kilometers, so has discontinued production and exports.

After the outcome of the airline operating the front Ansarolá (Partisans of God) claimed responsibility for the attacks.

Yemeni resistance in recent months has carried out operations with drones and missiles against different targets within Saudi territory as air bases and other facilities. In May, Houthis drones attacked a major pipeline running east-west of the kingdom and connects the Red Sea with the Persian Gulf, the attacks occurred in the districts of Dawadmi and Afif, west of Riyadh, in August another attack caused a big fire in the liquefaction of natural gas in Shaybah, also from the national company Saudi Aramco.

Meanwhile the official Saudi press agency reported that the flames in Abqaiq facility and Khurais were already under control, not to mention whether there were casualties among the staff, which also work many foreigners, particularly Americans.

With this attack, the kingdom will stop producing about 5.7 million barrels per day, which means five percent of the world's oil supply, more than half of the production of Saudi Arabia, the world's largest oil exporter.

Since the attack took place at dawn on Saturday there was no immediate effect on world oil prices, although experts believe that "will be a big blow to production", so that will affect only markets open on Monday. On Friday Brent benchmark crude, it closed at \$ 60.15 had a barrel.

The potential oil pressure that these attacks have caused forced the Department of Energy of the United States, to announce the same on Saturday just the news broke, he was ready to release oil from their strategic reserves if necessary.

Spokesman headed by Riad coalition, and with the full support of the United States and its Western allies, Colonel Turki al-Malki said: "They are conducting investigations to determine the parties responsible for planning and executing these terrorist attacks "and adding that the coalition would take the necessary measures" to safeguard national assets, international energy security and ensure the stability of the global economy. " Although it is still too early to assess damage to facilities and as to affect oil production. In this direction, the top executive of Aramco, Nasser Amin, reported that in 48 hours the company would have more information, to set the level of lost production.

Recall that Riad initiated the conflict against Yemen when after his resignation, the Yemeni President Abd-Rabbu Mansour Hadi, was exiled in Saudi Arabia, leaving his country in the midst of a civil war, so it was bound by the own Saudis to give reverse its resignation, violating all laws and giving a "legal" framework to justify the advance of the coalition that has generated a real genocide against the Yemeni people, in addition to the bombings, which have caused nearly 110 people dead he is being punished by the famine affecting more than thirteen million people and different epidemics that are already adding thousands of deaths over, so that the United Nations has defined this conflict as the worst humanitarian crisis today.

The usual suspect

The United States Secretary of State, Mike Pompeo, quickly came to accuse Tehran of Saturday's attacks against Abqaiq and Khurais, although the front Ansarolá are mostly Shiite, like Iran, in the four years and seven months leading this war the United States or any foreign intelligence agency, have demonstrated some element that connects them. Although, truth be told, it is widely known collaboration that the coalition of Saudi Arabia along with a dozen Arab countries, is supported by the United States, Israel and several Western nations, why the Islamic Republic of Iran, no he could support his brothers?

Pompeo, in his message directly accuses Tehran twitter saying that "there was no evidence that the attacks came from Yemen, so it had to come from Iran," former CIA Director Trump also ups the ante and adds. "Amid all calls for reducing the scale, Iran has launched an unprecedented attack against the world's energy supply."

The US government has blamed Tehran for at least a hundred attacks against Saudi Arabia, without providing evidence. This obsession is part of the campaign of harassment that has developed foreign policy of Donald Trump almost from the start of term in January 2016.

Donald Trump, in a communication with the crown prince, Salman bin Muhammad, the strongman of the Saudi regime, offered his support to self-defense of the realm, so it might be opening the door to the escalation of the conflict.

This attack and new accusations from Washington to Iran come at a crucial moment in the difficult relationship of government Trump with the government of President Hassan Rouhani, since from the United States unilaterally withdrew from the nuclear deal with Iran known as G 5 + 1 in May 2018, restoring economic sanctions, the Persian country freed of those obligations, which imposed to limit its nuclear research, Tehran resumed his work on uranium enrichment, exceeding more than a month ago the level established in the agreements of 5 + 12015.

These attacks also come at a time that Trump very slyly had hinted he would be willing to begin talks with Iran outside the framework of the upcoming United Nations General Assembly in New York, which will occur in late September, so now you could be in doubt.

The Republican senator from South Carolina, Lindsey Graham, one important ally Trump tweeted that "Now is the time that the United States produce an attack against Iranian refineries if they continue their provocations or increase the nuclear enrichment."

The situation after Saturday's attacks does much more confusing the picture, which could rush into an open conflict between Iran and the United States, where players very interested in this to happen, primarily Israel, could perform some action to finally your wishes They are met, beyond the thousands of deaths that their interests could produce.

Illegal Fishing and Maritime Drug Trafficking: Crime Convergence

It is known as illegal, unreported and unregulated (IUU onwards), to capture ocean wildlife illegally and unregulated. Illegal fishing is fast becoming one of the most lucrative illicit activities, generating some 23,500 million dollars in profits worldwide. Transnational Criminal Organizations (hereinafter: OCT) are the ones who are at the forefront of this criminal activity (FAO, 2018).

IUU fishing takes advantage of the gaps and shortcomings of the laws of regimes national and international management, poor countries' capacities to make presence in their territorial waters and the few initiatives of control and surveillance especially in sensitive areas.

This transnational crime has the potential to eliminate artisanal fisheries, especially predation of highly migratory species. According to the report State of World Fisheries and Aquaculture 2016, issued by the Food and Agriculture Organization of



the United Nations (hereinafter FAO, for its acronym in English): "IUU fishing is a threat to livelihood, exacerbates poverty and increases food insecurity "(FAO, 2018).

IUU fishing and overcapacity of fishing fleets worldwide are the main threats to the sustainability of fisheries resources in the world, this is the biggest reason why fleets move their operations to new areas, especially areas




protected.

This phenomenon is no stranger in the Pacific area this tropical, fishing fleets have moved their activities to neighboring areas of Marine Protected Areas (hereinafter: AMP), especially Costa Rica (Cocos Island), Panama (Isla Coiba), Colombia (Gorgona, Malpelo Island) and Ecuador (Galapagos Islands), among others; these fleets looking to capture its surroundings to protected species and highly migratory species, in many cases illegally entering jurisdictional maritime areas, exclusive economic zone and waters of the marine reserve of each country.

According to the book "Illegal fishing marina in Colombia" presented by the Attorney General and the NGO MarViva, it states that in the 2014-2017 period, the government agency National Parks of Colombia has registered about 254 sanctions in the Pacific Ocean and 20 in the Atlantic for illegal fishing in protected natural areas. Parks where more cases were presented Sanctuary of Malpelo


Fauna and Flora (152) and the Gorgona Natural National Park (83) in the Colombian Pacific.



In the case of the Galapagos Marine Reserve (Ecuador), declared a Natural World Heritage Site, more than 300 ships, especially Chinese flag fishing nearby. On August 13, 2017, the Navy of Ecuador captured a ship Chinese flag named "Fu Yuan Lu Leng 999" in jurisdictional waters of the Marine Reserve and therefore in Ecuadorian EEZ with 300 tons of fishing of endangered species, vulnerable and protected as the hammerhead, all highly migratory.

Because of this incident, we proceeded with the capture of 20 people and the seizure of the ship, setting an environmental crime.

As the drug by sea -second link in the value chain by the preferred drug trafficking OCT for transport alkaloid, means there is a natural link between these two forms of transnational crime.



"This illegal activity, in addition to damaging the ocean and fishing unceremoniously species, is accompanied by other illicit activities such as arms smuggling, people and narcotics trafficking," he explained the president of Costa Rica, José María Figueres on the occasion of the World Ocean Summit, held in Cancún Mexico in March this year.

The links are manifested because the media, ie fishing boats are used both for narcotics trafficking, refueling (known as floating petrol stations) and for illegal fishing and in a few cases for the two offenses transnational simultaneously; Such is the case of a vessel Costa Rican flag called "Success 1", which in 2016 was intercepted by a patrol boat of the Navy of Colombia in the vicinity of the Malpelo Island with 626 kg of cocaine and 1200 kg protected fish species (more than 90% white shark). Five Costa Rican and Nicaraguan were captured and turned over to the relevant authorities in Buenaventura (Department. Of Valle del Cauca).


Likewise, reports of seizures and anecdotal evidence indicate that the OCT are using the

maritime scene around marine protected areas as routes for smuggling cocaine hydrochloride (hereinafter HCL), this can infer the following events in CIMCON records, from 2017:

- Cocos Island National Park: on April 15, 2017, the Costa Rican authorities seized 969 kg of HCL.
- Coiba National Park: on December 2, 2016, the SENAN seized 604 kg of HCL which was transferred into a go-fast boat type.

- Gorgona Natural National Park: on August 6, 2015, seized 1,300 kg of LCH were in two boats. 21 November 2017, was captured a vessel with 720 kg of HCL. 15 January 2018, were seized 336 kg of HCL.
- Sanctuary of Malpelo Fauna and Flora: the May 10, 2016, seized 1,180 kg of HCl and 11 February 2018, 94 kilograms of HCL floating on the surface were seized.
- Galapagos Marine Reserve: February 21, 2016, seized 700 kg of LCH were transported in a go-fast boat type. On March 13, 2016, 1.9 tons of HCL were seized. 31 July 2017 were seized 600 kg of HCL. On April 12, 2018, they were seized 1,600 kg of LCH were transported by fishing vessels.

The United Nations Organization on Drugs and Crime (UNODC, for its acronym in English), in its World Drug Report 2017 states that: "Organized criminal groups have expanded their range of illicit activities. They have other criminal sectors, such as cybercrime and environmental crime emerged. Fewer and fewer groups are dedicated solely to drug trafficking and increasingly also active in other sectors illicit "(UNODC, 2018).



Anecdotal evidence of state entities, involved in combating drug trafficking by sea, realize that these protected areas are sites chosen by the OCT for refueling ships seeking to get drug off the coast of Mexico and Central America, being thus the main drug trafficking routes by sea.

IUU fishing is a crime that it referred to as a "crime of convergence" because usually committed along with other crimes, especially drug trafficking by sea. The collaboration of state control agencies to create an adequate response to these events is vital in order to ensure the sustainability of the ocean and deny the use of the sea to organizations carrying drugs by sea.

Countries in the region are channeling their efforts to combat this convergence of crime, so much so that Costa Rica has installed a radar in Cocos Island to control the Marine Reserve and also in the acquisition process a King Air 250 aircraft, "which will go

to the fight against drug trafficking and illegal". Ecuador meanwhile has mobilized its resources available to their territorial waters west of the Galapagos Islands in order to exercise sea control and prevent illegal fishing in its waters, especially in the declared Marine Reserve area around the Galapagos Islands.

However, individual efforts are not enough. The obvious concurrency requires that regional synergy, as an accelerant to success in the fight against drugs, materialized through operations simultaneous, concurrent and overlapping maritime interdiction can not put aside the fight against crime is adopted convergence closely related to drug trafficking as it is IUU fishing.

Planning Operations Maritime Safety should cover both drug trafficking and illegal, under the support of local laws, respecting the sovereignty and jurisdiction Territorial Sea and Exclusive Economic Zone of each State and protected by international instruments such as the United Nations Convention Convention on the law of the Sea 1982 (UNCLOS), the Convention of the United Nations Convention against Illicit Traffic in Narcotic Drugs and psychotropic substances of 1988 and the New York Agreement of 1995 UN Stocks Straddling Fish Stocks and Highly Migratory Fish Stocks among the most important.

Peru terrorist actions cover a wide spectrum of organizations among which include local and foreign criminal gangs, cells of the Islamic State and Hezbollah, Maoist Shining Path remnants, among the main ones.

Chronologically the highlights were:

16SET2019: Detect 20 ways to conceal illegal chemical inputs that were to be sent to criminal groups VRAEM (Valle de los Rios Apurimac, Ene and Mantaro). From 12,947 kg ENE2019 confiscated.

18AGO2019: The Peruvian government declared to extend the state of emergency for 60 days in 6 districts of the Amazonian department of Madre de Dios (south), where operations to combat illegal mining are made. Mercury in the Plan for the development of 2019, 300 soldiers and 1,200 policemen involved.

Informal mining and illegal.

- Influencing factors:
 - Absence or weak presence and state control. Population with UBN (Unsatisfied Basic Needs).
- Risk factors that can influence regional security: Drug Trafficking: Halla another source of funds to finance. Terrorism: Halla land management and resources for financing. Human Resource Exploitation by working conditions. Environment contaminates waterways mercury and arsenic.

social violence disputed areas and profit from exploitation. illegal trafficking in explosives and people (labor and prostitution). Corruption of local authorities.

Informal mining becomes illegal when it relates to crime and becomes a cause of action

16JUL2019: Detained Brian Eugenio Alvarado Huari (23 years, Peru) follower of the Islamic State at home (San Juan de Lurigancho), while learning to handle explosives. Capture occurs a few days after the opening of the 2019 Pan American Games Lima (26JUL-11AGO2019).

In MAY2018: 11 detainees in Brazil linked to the Islamic State, who have been planning an attack in the carnival in Rio de Janeiro. One of the detainees have had contact with a Peruvian via WhatsApp, which was identified as Brian Alvarado.

11SET2018: Life imprisonment for the cupola of the Shining Path (Maoist) for assault (400 kgs of explosives) (25 dead and 155 wounded) in Miraflores (Lima suburb, 16JUL1992). Abimael Guzman (83 years), the 2nd life imprisonment (i car bomb next to 9 terrorists).

03AGO2018: Detained Venezuelan criminal gang "Inglorious of Aragua Train" when trying to rob bank branch inside a shopping center in Lima - Peru. Aragua train (500 mobsters belonging to the union of railway operations center Tocorón prison - Venezuela).

08JUN2018: 4 policemen killed by terrorist bombing Victor Quispe Palomino clan, Shining Path dissidents in Huancavelica, Apurimac Valley VRAEM rivers, Ene and Mantaro, where they move in alliance with narcos, remnants of Sendero Luminoso.

06-13NOV2017: First military maneuvers in the Amazon in Brazil, Peru and Colombia, with US participation. OBJECTIVE: To increase the "multinational response capacity in Brazil, especially in the field of humanitarian logistics and confrontation of the 4 countries to transnational crime."

13MAR2017: Peruvian Secta New Israeli Mission Church Universal Pact, dominates the coca-growing areas on the border with Brazil.

27OCT2014: Muamad Amadar (28 years, Hezbollah, Lebanon) is arrested in Surquillo (Lima District), having handled explosives in the house where he was staying. After the operation, the police found in the trash terrorist, remains of detonators, TNT and black powder.

Analysis and Conclusions

1. In recent years, the Lebanese terrorist group Hezbollah extended its networks in Latin America. There are cells Shiite militia Hezbollah: in Argentina, Venezuela, Bolivia and Ecuador. In development: Uruguay and Peru 2. Currently a remaining Shining Path faction, carried out sporadic ambushes and clashes with security forces in an Andean area of Peru, considered focus on the production of coca leaf and cocaine, in alliance with drug gangs.


3. The US military presence in the triple border of Peru, Colombia and Brazil, would aim to neutralize armed insurgencies and their support networks, for ideological reasons and / or religious

4. Several former Peruvian Shining Path guerrillas, would be based in Buenos Aires, as members of drug gangs 5. The main threats to Peru, would be drug trafficking and remnants of the Shining Path Maoist guerrillas, however, emerging cells Hezbollah and probably Islamic state in the region, requires research, coordination and exchange of information flowing services Peruvian security with all neighboring countries in the region.

6. Leaders of Movadef (Movement for Amnesty and Fundamental Rights), with ideological bases in Peru, Chile, Argentina, Uruguay, Mexico and Europe, are accused of advocating terrorism to defend the ideas of Shining Path leader, Abimael Guzman (Maoísta group Terrorista). FUDEPP (Front and Defense Unit of the Peruvian people) and Movadef were considered, political arms of Sendero Luminoso.

7. The presence of Turkish diplomacy in Chile, Peru and Ecuador seek among other tasks, support its counterterrorism policy.

8. Shiite Islamists linked to the Iranian Revolutionary Guard in Latin America have recruited many Peruvians, whom after converting to Islam, have completed their training in Iran.

Saudi Arabia between Vietnam and 11 S.

It is very difficult for Saudi Arabia to reverse the course of the war declared against Yemen, and believed solve without too much difficulty. Now, after four and a half years, he knows that will never achieve rid of the taste of defeat, beyond that still, finally, can technically realize a win.

The crushing blow on Saturday 14 September, which meant the attacks houtie resistance plants of the Saudi-Aramco, (See: Yemen. More storms in the Persian Gulf) and those made particularly in the refinery Abqaiq, the world's largest, was a response not calculated the attacks led by the Saudis, who have caused irreparable damage to Yemen and mainly in its population, 120 thousand dead, millions injured, thirteen million people food crisis coalition , the largest since World War II, many epidemics that threaten to raise still more the number of dead.

Despite all this, is the Saudi kingdom, who seems on the verge of a terminal crisis, fundamentally political, in which if you still did not fall it is only because his government continues to buy time at the expense of its infinite resources to the United States and the European Union, two giants who have enriched themselves outrageously, not just arms sales last generation, civil and military aircraft, oil machinery, megalomaniac projects engineering and architecture, but also large quantities of production of goods luxury jewelry, watches, clothing and all the paraphernalia of accessories that make this industry beyond the crises in their home countries to stay alive.

It would not be very attractive to American voters, who know very well the war equation - taxes. Perhaps in this context that we must read the recent expulsion of John Bolton from his post as National Security Advisor, a sinister that certainly in this new reality that has opened, after the Houthis attacks have already prompted a war against Iran without stopping at details (Ver. Trump the grotesque use of power.)

Anyway, ads Pentagon have provoked a swift reaction from Tehran warned, through the commander of the Revolutionary Guards, Hossein Salami, "that an attack occur Iranian territory responsible country will become a field battle "in obvious reference to Saudi Arabia who barely separate them between two and three hundred kilometers across the Persian Gulf. The statement adds that Commander Salami: "We will never allow war reach our territory. We will not stop until the destruction of the aggressor and not leave any safe place ".

Calculations made after Saturday's attacks fourteen, said that Riyadh would be losing about \$ 300 million per day. A few hours spokesmen attacks Saudis had announced that while it was too early to draw conclusions, the damage would take several weeks to be repaired. Oil production since the kingdom has halved. Such economic damage as a domino effect has spread worldwide, the Yemeni resistance has achieved a military operation that barely reaches 200 thousand dollars, that is 20 thousand dollars for each drone of those who participated.

Although losses of the Saud family, not just limited to the political and economic, in the course of the war has left thick bruises on relations with two key allies Egypt and the United Arab Emirates have not only withdrawn from the war but as did Qatar, they noted the intention of improving relations with Tehran.

Inaction by the United Nations has tolerated the Yemeni genocide also seems to be veering and has begun to raise the voice in denouncing Riyadh, responsible for one of the worst military disasters in modern times.

which could lead to a regrouping of internal and external enemies of the Prince. Despite the current course of the war with Yemen, threatening the stability of the Saudi government, Prince MBs, she refuses to sit down and negotiate a solution to end this carnage.

After learning of the attack immediately, the head of the US State Department and former CIA chief Mike Pompeo blamed Tehran, denying the possibility that the drones have departed from Yemeni soil since Yemen suffers a military embargo Washington and London, making it impossible to access that technology and undermining the ability and resourcefulness of the Houthis, the same that have enabled them to withstand up to now placed the main ally of the United States in the region, Saudi Arabia, in a strange place located between Vietnam so hard to leave and September 11, 2001, by the critical situation in which the kingdom is.

How often quite patents and reach atenazar in some cases, many know well their own weaknesses; therefore, they do their best to overcome them or at least try to hide others. Mainly those engaged in public life or are exposed to constant observation.

No need to analyze in detail the behavior of the individual concerned, one can say that from his presidential campaign, promised his electorate to many things that did not comply. Including bringing to justice Hillary Clinton, he says, their lies, illegal wiretapping, confabulations and implications with some Russian plot to discredit him; which apparently it was well; but completely backwards.

Plaza-Angulo (2011) tells us about it:

The concept of knowledge management has two components, on the one hand, on the management, which at the organizational level results in the adoption of functions such as planning, organization, management and process control to achieve the objectives, the mission and vision of these organizations; and secondly, the ability and talent of individuals and organizations transform information into knowledge, generating creativity and innovation, which provides security and encourages decision-making. All workers should be involved fully in the implementation of the improvements that are proposed.

Competence Management is a process that identifies the capabilities that will be required of people to fill each job, this is achieved by developing measurable and objectively measurable profile. The profile is developed, should be aligned with the organizational culture and strategic business lines, containing the competencies deemed necessary for the proper performance of the functions of each position. Thus, the direction will have the certainty that in every job there is a suitable person working to achieve organizational goals.

Finally, continuous learning, is to provide people the motivation and opportunity to improve the skills and talents that are necessary for the performance of his current position, or which is expected to play in the future.

Thailand Royal Thai Army Special Warfare Command

The Royal Thai Army is responsible for protecting the sovereignty of the kingdom. It is the oldest and largest branch of the Royal Thai Armed Forces. This army was formed in 1874, partly in response to new security threats emerging after the Bowring Treaty of 1855 with Britain, which opened the country to international trade.



This army has a long history of coups and attempted coups. His leadership continues to see the coup as one of its roles. For example, on May 22, 2014, the army overthrew the government appointed military officers to the National Assembly, and August 21, 2014 elected the commander of the army, General Prayut Chan-o-cha, as prime minister. This coup was the 18th in the history of Thailand.

Organization
